1) Konbit: Scholarship and Operational Support for St. Paul's School Funds from CHP helped establish the St. Paul School in the early 1990s, and CHP started the Konbit Education Program in 1996. Funds designated to the Konbit program support the education costs and health care needs of the over 300 pre-K through 10th grade students that attend the school each year. Funds are also directed to operational support for the school including living wage teacher salaries, supplies, and equipment to ensure the highest level of education quality. Over the past several years St. Paul's has been awarded the Highest Standard of Excellence by the Haitian Ministry of Education, and is widely considered a top school in the program. The school, and CHP support, caters to and is open to all sectors

CHP partners with the community of Petit Trou and the Haitian Ministry of Health and Population (MSPP) to strengthen access to quality healthcare for all in the community. CHP community health activities revolve around an unprecedented memorandum of understanding (MOU) with the MSPP, community of Petit Trou, and the Episcopal Diocese of Haiti that focuses on building a comprehensive, responsive, and equitable health system for the region. In 2014, CHP sponsored 26 village health volunteers to become official, trained Community Health Aides to support MSPP health outreach services in their respective remote rural communities. CHP installed solar panels at the Petit Trou MSPP clinic to ensure consistent electricity, supported structural improvements, and provided needed equipment and training to MSPP staff at the both the local clinic and at the closest MSPP referral hospital. CHP provided opportunities for outreach to Colorado medical professionals and corporate partners that want to partner with us in our health work in Haiti. This included a new partnership with Boulder Community Health, who on their first mission to Haiti trained and equipped community health workers with life-saving tools and skills to promote health in remote rural location.

Various projects including Gonaives, Share and Outreach.

Water, Infrastructure, Sanitation, and Hygiene (WISH) Program:

Lack of access to clean water was a constant burden in the life of every family in the Petit Trou area. People needed to hand carry water from a water source sometimes up to two hours away to their home. Over the past several years CHP worked closely with the community to construct 12 safe water wells within a ten minute walk of all households and provide hygiene and sanitation education. In 2014 CHP focused on scaling-up and fine tuning WISH activities. This included maintenance, repairs, and training of

community members for the water wells, vigilance of the minor structural damage at the St. Paul's campus caused during the 2010 earthquake, and upkeep of the cafeteria, hand washing stations, and the bathrooms and septic systems at the School. Resources also supported two local Haitians who were trained to provide hygiene and safe water education programs in the surrounding communities, and initiated a strategy to mobilize communities to form community water committees for each well.

1) Konbit: Scholarship and Operational Support for St. Paul's School Funds from CHP helped establish the St. Paul School in the early 1990s, and CHP started the Konbit Education Program in 1996. Funds are also directed to operational support for the school including living wage teacher salaries, supplies, and equipment to ensure the highest level of education quality. Over the past several years St. Paul's has been awarded the Highest Standard of Excellence by the Haitian Ministry of Education, and is widely considered a top school in the program. The school, and CHP support, caters to and is open to all sectors of the local population regardless of race, religion, or financial means. St. Paul's regularly hosts students from economically difficult circumstances and provides extra support to these students and their families to ensure their continuing attendance and participation. Vocational Program:

The people of Petit Trou identify poor household income and livelihood support as one of the most serious problems they face as a community. Indeed poverty and low resources impacts all aspects of growth and development. The Colorado Haiti Project began partnering with the community four years ago looking for ways to develop economic opportunities in the region. The program has focused on providing scholarships for local students for continuing education with the goal of having these trained resources return to the community, as well as entrepreneurship training opportunities. In 2014, the CHP scholarship program supported twelve students in continuing education. Scholarships were offered in education, accounting, auto mechanics, plumbing, construction and agriculture. The Vocational Development program also supported courses in Entrepreneurship for middle school students, and the establishment and training of a sewing atelier for 16 young women as an alternative to costly continuing education.

Community Health Program:

CHP partners with the community of Petit Trou and the Haitian Ministry of Health and Population (MSPP) to strengthen access to quality healthcare for all in the community. CHP community health activities revolve around an unprecedented memorandum of understanding (MOU) with the MSPP, community of Petit Trou, and the Episcopal Diocese of Haiti that focuses on building a comprehensive, responsive, and equitable health system for the region. In 2014, CHP sponsored 26 village health volunteers to become official, trained Community Health Aides to support MSPP health outreach services in their respective remote rural communities. CHP installed solar panels at the Petit Trou MSPP clinic to ensure consistent electricity,

supported structural improvements, and provided needed equipment and training to MSPP staff at the both the local clinic and at the closest MSPP referral hospital. CHP provided opportunities for outreach to Colorado medical professionals and corporate partners that want to partner with us in our health work in Haiti. This included a new partnership with Boulder Community Health, who on their first mission to Haiti trained and equipped community health workers with life-saving tools and skills to promote health in remote rural location.

Various projects including Gonaives, Share and Outreach.

Water, Infrastructure, Sanitation, and Hygiene (WISH) Program:

Lack of access to clean water was a constant burden in the life of every family in the Petit Trou area. People needed to hand carry water from a water source sometimes up to two hours away to their home. Over the past several years CHP worked closely with the community to construct 12 safe water wells within a ten minute walk of all households and provide hygiene and sanitation education. In 2014 CHP focused on scaling-up and fine tuning WISH activities. This included maintenance, repairs, and training of community members for the water wells, vigilance of the minor structural damage at the St. Paul's campus caused during the 2010 earthquake, and upkeep of the cafeteria, hand washing stations, and the bathrooms and septic systems at the School. Resources also supported two local Haitians who were trained to provide hygiene and safe water education programs in the surrounding communities, and initiated a strategy to mobilize communities to form community water committees for each well.
